MEMBER RELEASE OF LIABILITY

By my signature below and entry fee payment, I acknowledge that I am considered a "Third Party member" of Shoreline Riders, Inc. for the weekend of July 14, 15 and 16, 2017. I am considered to have all the membership entitlements, except voting rights. I, the Undersigned participant, acknowledge that I voluntarily applied to participate in the activity, sponsored by Shoreline Riders, Inc.

I acknowledge that horseback riding is a sport which carries inherent risks of injury and damage to me, my horse and my property. **I KNOWINGLY ASSUME ALL RISKS, WHETHER KNOWN OR UNKNOWN, OF HORSEBACK RIDING.** Also, I RELEASE SHORELINE RIDERS, INC.
