We have been given the privileged use of this property for camping and riding from private landowners. The following rules are for their safety and ours. We want everyone to have a safe and fun time and be able to come again to this paradise in the redwoods.

**EXTREME FIRE DANGER, No camp fires - NO SMOKING on the trail**

Adult Beverages cannot be served on the trail

No Animals in the BBQ/Community Camp Area

No dogs on the trails. Dogs must be on leash or secure in your camp at all times or we will lose the privilege of allowing dogs at all.

NO FIREARMS - NO STALLIONS

River riding may be limited or off limits completely, please check with ride committee

Every horse must have a rider. Bring your own feed for horses

There may not be a vet on the premises, be prepared for emergencies

**THIS IS A MODERATELY CHALLENGING RIDE. WE RECOMMEND ALL HORSES BE SHOD (BOOTED) FOR ROUGH TERRAIN AND IN GOOD PHYSICAL CONDITION \*EVERYONE must be pre-registered. Please do not invite people to the camp without pre-registering and paying in advance.**

All riders under the age of 18 must be accompanied by a parent or legal guardian *at all times*.

DIRECTIONS: Highway One, 7 Miles N of Fort Bragg, East on Ten Mile Haul Road (past 10 Mile Camp One rd), 4 miles to Camp. This is an ACTIVE LOGGING ROAD, use caution and drive slowly. **ABSOLUTELY NO ACCESS ALLOWED UNTIL 5 PM FRIDAY** - trucks will be running and have the right of way.
