

# Spring Grass

How it Affects Horses & Ponies (by Maggie Carty)

# **Key Takeaways:**

- Spring grass is fresh forage that can be a great source of nutrition for horses and ponies, but monitoring how much and how often they graze is critical.
- Careful management of grass intake, including time of day of turnout, helps lower chances of digestive upset and colic.
- A good muzzle, like the <u>Flexible Filly Slow Feed Grazing Muzzle</u>, can limit how much grass your horse can access.
- Horses should be gradually introduced to spring grass to reduce the <u>risk of laminitis</u> or other digestive issues.

# . How Does Spring Grass Affect Horses?

- Overconsumption of spring grass can cause colic, laminitis, or other serious health issues that require prompt veterinary attention.
- This is because lush spring grass contains much higher levels of sugar and carbohydrates than dried hay, as well as increased amounts of certain minerals like potassium. These can lead to digestive issues if the horse consumes too much.

## Approved Minutes from March 12, meeting

Approval of Last Month's Minutes: The minutes from February 20th, 2024 were read by Tina. Janet made corrections. Aura motion, and Carol 2nd to approve the minutes. Motion Approved.

#### **Officer Reports:**

Treasurer (Janet): The checking/savings report from 02/19/24 to 03/11/24 was read by Janet. The beginning balance was \$16,377.70 and ending balance was \$17,933.25. More membership dues came in, and several bills were paid. Motion to approve by Sarah, Kim 2nd. Motion approved.

#### **Committee Reports:**

#### Non Agenda Items:

SRI Needs Funds, Our Ability to Raise Money, Use of the club for other Activities

A group discussion was held again on how to raise funds for our club in light of not being able to afford a Rodeo. Ideas that include activities on non-horse events such as renting out the clubhouse for weddings have certain drawbacks due to excessive noise and traffic. Neighbors have already complained once. Skylar has an upcoming Project Now kids activities through the local Police Department that could add young members to the club through horse activities. Insurance is available through the Project Now, and Skylar has insurance. Participants would visit the arena with Skylar 1-2X week for 6-8 weeks. We agreed participants could pay regular membership dues and skip the initial add on fee for the first year. Once SRI has insurance coverage again we will revisit approving this idea.
