## BOARD OF DIRECTORS

## SECTION 1: POWERS

The management of the affairs, property, business, and control of policy is vested in the Board of Directors.
SECTION 2: NUMBER OF MEMBERS
The Board of Directors shall be composed of the following ten or eleven members:
A. The President, Vice-President, Secretary, and the Treasurer, each having one vote.
B. The immediate Past President, having one vote.
C. Six elected Directors, each having one vote. Also, two alternate Directors to act and vote in full capacity when a regular Director is absent.
D. Two Junior Directors may be included, but shall have no vote.
E. No two members of the same household, excluding Junior Directors, may serve on the Board of Directors at the same time.
The Corporation shall have a President, Vice-President, Secretary, and Treasurer who shall be elected by a majority of the votes cast at the Annual Meeting of the Corporation to serve a term of one year and until their successors are elected. The term of office shall begin upon adjournment of the Annual Meeting. In order to qualify for office, a nominee must have been a member in good standing for a period of one (1) year immediately preceding the Annual Meeting. All elections shall be by secret ballot. The directors shall be elected by a majority of the votes cast at the Annual Meeting of the Corporation to serve for a period of one year and until their successors are elected. In order to qualify for election, a nominee must have been a member in good standing for a period of one year immediately preceeding the Annual Meeting. Elections shall be by secret ballot.
A. The President shall preside at all meetings of the Corporation. He/she shall be a member. Ex- officio. of all regular and special committees, and shall perform such duties and exercise such other powers as are usually incident to such office. In the absence of Bylaw or rule herin, Robert's Rules of Order will prevail.
B. The Vice-President shall perform the duties of the President in his/her absence or inability to serve. He/she shall perform all the duties incident to his/her office or which are properly required of him/her by the Corporation, President, or the Board of Directors.
C. The Secretary shall keep a complete and accurate record of all proceedings of the Corporation and the Board of Directors. He/she shall compile and report any changes in the rules passed by the Board of Directors. He/she shall have possession of these records, attend to the proper publication of all reports, conduct official proper publication of all reports, conduct official correspondence, attest documents, perform such other duties as are usual to such office, or as may be required by this Corporation, President, or the Board of Directors.
D. The Treasurer shall have custody of all monies of the Corporation and shall keep a regular book of accounts. He/she shall disburse the funds of the Corporation in payment of just demands against the Corporation, after approval by the Board of Directors, taking proper vouchers for such disbursements and shall render to the Annual Meeting of the Corporation, the Board of Directors, and regular club members from time to time as may be required of him/her, an account of all his! her transactions as Treasurer and of the financial condition of the Corporation. He/she shall perform all the duties incident to his/her office or which are properly required of him/her by the Corporation, President, or the Board of Directors.

There has been some confusion about committees and the responsibilities of the chair and committee members. Here are some quick definitions to help.

Committee Chair responsibilities. He or she plans agendas for committee meetings to accomplish the committee's goals. The Committee Chair and staff liaison are responsible for keeping leadership and appropriate staff fully informed of committee activities. The Chair is an important part of the team, but is not the boss. It is not your role to make all the decisions, or do all the work. It is your role to encourage and involve all committee members in whatever way they are able to contribute. Committees are required by this organization to report to the Board of Directors at the regular monthly meetings, get approval of all publications released i.e. entry forms, applications, etc. prior to such release; keep a record of monies involved and report and turn in to the treausurer with a complete report at the next monthly meeting or prior. Committees must maintain an approved budget for all spending.

The rules have been updated with previously approved changes and the addition of a "Protest" or complaint procedure. Rules are posted on our website as well as our facebook page.
