In consideration of my participation in events organized or sponsored by SRI/CSHA I, my representatives, heirs executors and assigns waive any and all claims for liability for injury or damage to myself, my animals, or my property arising out of my participation. I expressly waive any rights I may have under California Civil Code 1542, which states "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing this release, which is known by him must have materially affected his settlement with the debtor:.
